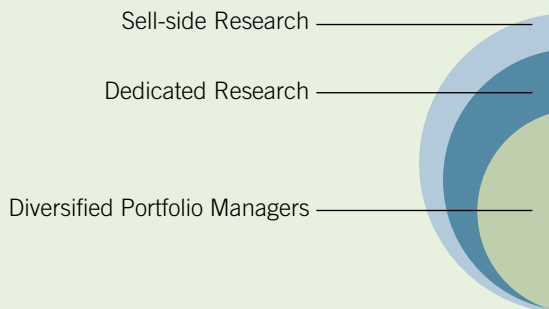
Research Excellence

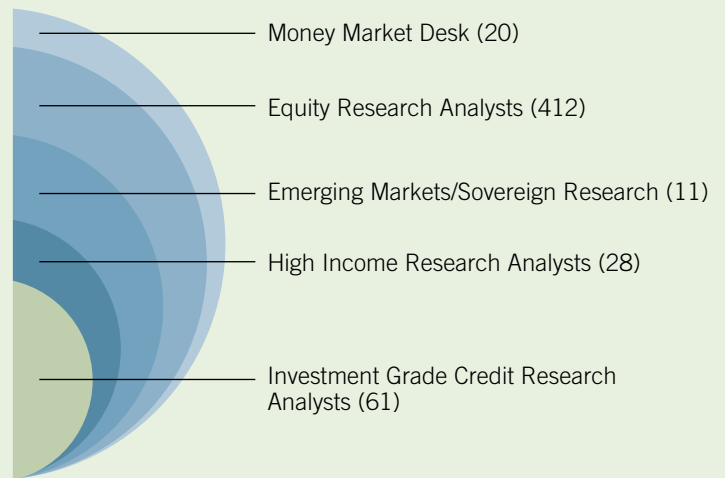

Global Resources

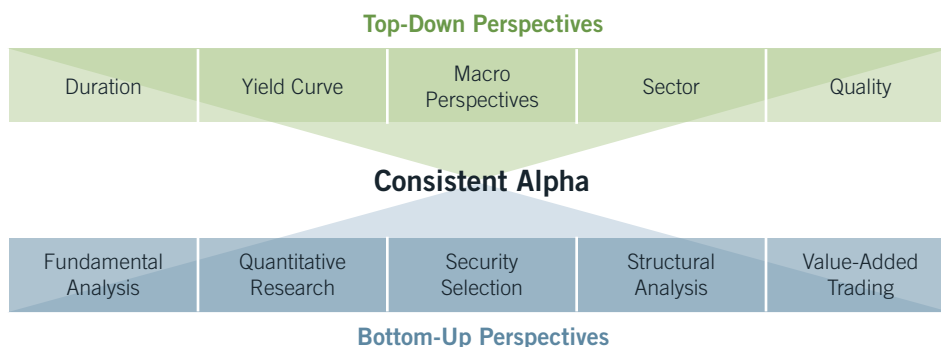
